Dear parents.

Greetings of the day! Hope you are safe and healthy.

In accordance with the circular no.490 dated 15.10.2021 issued by the School & Mass Education Department, Govt. of Odisha, the school management is going to reopen the school for class- VIII w.e.f 01.11.2021 strictly following the SOPs of Covid-19. The guidelines issued by the Govt. about re-opening of school is posted in the school website for reference of the parents & students. As per the guidelines, parents are required to submit their written consent through the prescribed CONSENT SLIP (Uploaded in the School Website) through their ward at the time of reporting at school for attending the offline classes. If any student is found having body temperature above 98.6 F or any infectious diseases or cough, fever & sneezing, the parents concerned is required not to send their ward(s) to school. School Bus service will not be provided to the students presently and the decision to this effect will be made latter on depending upon the Consent of the parents and finalization of the Bus Routes.

The offline school timing till further notice is given below.

The details of time table for offline classes will be shared by the Class Teachers in their respective WhatsApp Group accordingly.

On the reopening of the school the students are required to adhere the followings:-

- S Wear face mask without fail while coming to the school and carry an additional mask
  - H Bring the hard copy of the consent form to be handed over to the class teacher.
  - S Move into the school on the circles marked on the road/floor only, maintaining social distancing.
  - Produce the School Diary to the Security Guard for noting the body temperature during the Thermal scanning every day.
  - Sanitize hands near the Gate before entering into the classroom and also at the beginning of each period during the interval of 15 minutes in between classes.
  - Occupy their allotted seat only, after entering into the classroom.
  - Show the Diary to the class teacher to record the body temperature in the attendance register every day.
  - Not move here and there either in the class room or in the school premises during the school hour.
  - Maintain social distancing and use sanitizer/hand wash before and after going to toilet only during the interval between each period.
  - Inform the concerned Supervisor head, in case they misplace the mask during the school hours.
- Carry homemade Tiffin only.  
Not share Tiffin, water bottle, book, note book, pen, pencil or any other belongings with their friends.
- Dispose off the disposable masks, if any, in the designated dustbin.
  - Leave the vicinity of the school immediately after completion of the classes in staggered manner to avoid crowd/gathering near the school area.
